ORDINANCE NO. 22-08

AN ORDINANCE FURTHER AMENDING SECTION 6K.01, ARTICLE K, CHAPTER 5 OF ORDINANCE NO. 17-10, OTHERWISE KNOWN AS THE 2017 REVISED REVENUE CODE OF THE CITY OF BAGO, AS AMENDED BY CITY ORDINANCE NO. 19-17.

Explanatory Note:

WHEREAS, on February 4, 2022, CHED Regional Office No. VI made an on-site evaluation on Bago City College (BCC) where several conditions were laid down for it to acquire Institutional Recognition (IR);

WHEREAS, among these requirements is the revision of its tuition fee structure in order for it to be at par with other Local Universities and Colleges (LUC) whose tuition now ranges from P250.00 to P300.00/unit;

WHEREAS, on January 28, 2022, the Board of Trustees (BOT) of Bago City College (BCC) passed Resolution No. 01-22 entitled **RESOLUTION APPROVING TUITION INCREASE OF BAGO CITY COLLEGE TO P250.00/UNIT EFFECTIVE SCHOOL YEAR 2022-2023 AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD TO AMEND APPROPRIATE PORTION OF THE BAGO CITY REVUNUE CODE TO THIS EFFECT** which was taken up by the Joint Committees on Education and Ways and Means in a meeting on February 11, 2022;

WHEREAS, during that meeting the members of the Joint Committees were satisfied and convinced that an increase in the tuition fee for incoming freshmen for SY 2022-2023 is needed and for this purpose, portion of the Revenue Code of the City of Bago needs be amended;

NOW THEREFORE, upon motion of SP Member Cleo F. Gaudite, unanimously seconded by all members present, the Sanggunian ordained and it hereby ordains that:

SECTION 1. 6K.01 of Article K, Chapter 5 of Ordinance No. 17-10, is accordingly amended to read as follows:

“Article K. BAGO CITY COLLEGE CHARGES

Section 6K.01 Imposition of Fees. - Unless specifically provided, the following shall be the prescribed semestral fees of the Bago City College:

Furthermore, students enrolling for summer classes shall pay the corresponding fees for registration fee, tuition fee, salaries of teachers and adjustments in the cost of utilities and maintenance, and other necessary academic fees as may be assessed by the institution.

SECTION 2. Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

SECTION 3. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, which provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 4. Effectivity Clause. This Ordinance shall take effect upon its approval.
