ORDINANCE NO. 22-12

AN ORDINANCE AMENDING PORTIONS OF ORDINANCE NO. 21-15 OTHERWISE KNOWN AS AN ORDINANCE AMENDING THE CHARTER OF THE BAGO CITY COLLEGE.

WHEREAS, the Board of Trustees of the Bago City College has recommended for the amendment of certain portions of Ordinance No. 21-15 or the Ordinance Amending the Charter of the Bago City College;

WHEREAS, in the committee hearing of the Committee on Education and Cultural Affairs the proposed amendments to the BCC Charter was taken up and after due consideration was unanimously approved for consideration of the August Body;

WHEREAS, after a thorough deliberation on the matter, the August Body is of the consensus to adopt the recommendations of the Committee on Education and Cultural Affairs to accordingly amend portions of Ordinance No. 21-15;

NOW, THEREFORE, upon motion of SP Member Jozsef Mark Dexter M. Somcio, unanimously seconded by all members present, be it enacted by the Sanggunian Panlungsod that:

SECTION 1. Article III-A, III-B AND III-C are hereby inserted as follows:

"ARTICLE III-A – VISION, MISSION AND GOAL OF THE CITY COLLEGE

SECTION 1. VISION. – It is envisioned that the Bago City College be the center of quality education which develops competent and self-reliant graduates.

- SECTION 2. MISSION. It is the mission of the City College to develop the individuals who are innovative, service-oriented and globally competitive that contributes to the improvement of the quality of life and the community.
- SECTION 3. GOAL. The City College aims to provide affordable quality tertiary and technical education to Bagonhons and its entire student population that is at par with the standards and attuned to the achievement of academic excellence. Specifically, it aims to:
- 1. Create an environment that is conducive to the achievement of the full potential and holistic development of every student and honing them to be responsible and values-oriented individuals;
- 2. Provides student with strong foundations in academic and technical fields; and
- 3. Train and produce graduates who are competitive, with appropriate skills and expertise in their respective fields forming part of a pool of competent professionals.

ARTICLE III-B – ORGANIZATIONAL STRUCTURE OF THE COLLEGE

SECTION 1. There is hereby adopted and made an integral part of this Charter the Organizational Structure of the City College which is hereto attached as ANNEX "A".

ARTICLE III-C - FACULTY MERIT SYSTEM

SECTION 1. The Faculty Merit System as approved by the Board of Trustees in its Resolution No. 157, Series of 2021 dated October 22, 2021 is hereby adopted as ANNEX "B" and made an integral part of this Ordinance."

SECTION 2. ARTICLE V, Section 1, is hereby amended to read as follows:

"SECTION 1. There shall be created the Board of Trustees which shall direct and manage the affairs of the College ("BAGO CITY" was omitted). The ("SAID" was omitted) Board shall be composed of, but not limited to, the following member:

a. Chairman - Local Chief Executive

b.Vice-Chairman - President of the College/College

Administrator

Members:

- 1. President of the College Faculty Association;
- 2. President of the College Supreme Student Government;
- 3. President of the College Alumni Association;
- 4. Chairperson of the Sanggunian Panlungsod Committee on Education;
- 5. Accredited business or industry representative."

(NOTE: ALCU Representative was omitted)

SECTION 3. ARTICLE V, SECTION 3 is hereby amended to read as follows:

"SECTION 3. The City Mayor shall be the Chairperson of the Board of Trustees. In his/her absence, the Vice-Chairman shall act as the presiding officer of the Board."

SECTION 4. ARTICLE VIII, Sections 1 and 5 are hereby amended to read as follows:

"SECTION 1. The Search Committee for President/Administrator (SCPA) shall have five (5) members which shall be composed of the representative from the Civil Service Commission (CSC), Academe, business or industry sector, Association of Local Colleges and Universities (ALCU), and the Regional Office of the Commission on Higher Education (CHED). They shall choose from among themselves the Chairman and the Vice-Chairman. The Committee shall convene within 10 days from receipt of the notice to convene from the Chairman without the need of any resolution from the Board. Such notice shall be made not later than six (6) months before the expiration of the incumbent President/Administrator.

The Board shall appropriate adequate funds to finance the activities of the SCPA.

SECTION 5. The SCPA shall submit to the Board of Trustees the list of the top three (3) qualified candidates with 24 hours after the completion of the selection process and the Board shall select the next President/Administrator form that list."

(NOTE: "GOVERNING BOARD" was replaced by BOARD OF TRUSTEES, "SCP" with SCPA" while Section 6 was deleted)

SECTION 5. **SEPARABILITY CLAUSE.** - If any part or portion of this Ordinance be declared unconstitutional or invalid, the unaffected portion/s hereof shall remain in full force and effect.

SECTION 6. REPEALING CLAUSE. - All issuances, ordinances, rules, and regulations or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. **EFFECTIVITY.** - This Ordinance shall take effect immediately upon its approval.
