**ORDINANCE NO. 22-13**

**AN ORDINANCE DESIGNATING AND ASSIGNING THE CAMPUS OF BAGO CITY COLLEGE.**

**WHEREAS**, the Sangguniang Panlungsod had assigned the Lot Area presently occupied by the Bago City College (BCC) as its campus or for its academic purposes under Resolution No. 20-050 dated January 29, 2020;

**WHEREAS**, while the Sangguniang Panlungsod had already manifested its intent to devote the lot area occupied by BCC for its academic use, it is significant to institutionalize this grant through an ordinance duly enacted;

**WHEREAS**, after a thorough deliberation, the August Body is of the consensus on the enactment of an ordinance on the designation and assignment of the lot area for the campus of the BCC;

**NOW, THEREFORE**, upon motion of SP Member Jozsef Mark Dexter M. Somcio, unanimously seconded by all members present, be it enacted by the Sangguniang Panlungsod that:

**SECTION 1. TITLE.** – This Ordinance shall be known as the Bago City College (BCC) Campus Designation and Assignment Ordinance.

**SECTION 2. LOT DESIGNATION AND ASSIGNMENT BCC CAMPUS.** – In the light of the City's commitment to give Bagonhons affordable, accessible and quality tertiary education, BCC CAMPUS is hereby designated and assigned which shall be that contiguous portion of Lot 66-B-2-A covered by Transfer Certificate of Title No. 093-2015000171 situated in Brgy. Balingasag, Bago City, with an area of 24,330 square meters, more or less.

**SECTION 3. PURPOSE AND USE OF THE CAMPUS.** – The designated campus shall be used exclusively for academic and other related activities and objectives of the BCC.

**SECTION 4. SEPARABILITY CLAUSE.** - If any part or portion of this Ordinance be declared unconstitutional or invalid, the unaffected portion/s hereof shall remain in full force and effect.

**SECTION 3. REPEALING CLAUSE.** - All issuances, ordinances, rules, and regulations or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4. EFFECTIVITY.** - This Ordinance shall take effect immediately upon its approval.
