ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION OF TELEPHONE EXPENSES OF THE OFFICE OF THE CITY MAYOR, THE AMOUNT OF TWENTY EIGHT THOUSAND SIX HUNDRED EIGHT PESOS AND FORTY THREE CENTAVOS (PHP28,608.43), REPRESENTING THE PLDT TELEPHONE BILL OF THE PUBLIC ASSISTANCE AND COMPLAINTS DESK (PACD) FOR THE PERIOD OF DECEMBER 22, 2000 AND GLOBE TELEPHONE BILL FOR THE PERIOD OF SEPTEMBER 2021.
