ORDINANCE NO. 22-23

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATIONS OF TELEPHONE EXPENSES OF THE OFFICE OF THE SENIOR CITIZENS AFFAIRS AND PERSON WITH DISABILITY (PWD), THE AMOUNT OF SIXTY EIGHT THOUSAND EIGHT PESOS AND FORTY EIGHT CENTAVOS (PHP68,008.48), REPRESENTING THE PLDT TELEPHONE BILL OF THE PERSON WITH DISABILITY OFFICE (PDAO) FOR THE PERIOD OF MAY 16, 2019 TO DECEMBER 16, 2019 AND JANUARY 2020 TO FEBRUARY 16, 2020.
