## **RESOLUTION NO. 22-001**

**WHEREAS**, in an Indorsement letter dated January 4, 2022 from the Honorable City Mayor, respectfully referred to this Honorable body, the request of Mr. Caruso T. Villaflor, Jr., City Treasurer, this City, for the passage of a Resolution authorizing the setting up of a Petty Cash Fund for Calendar Year 2022 in the amount of Five Hundred Thousand Pesos (₱500,000.00) Only;

**WHEREAS**, the Petty Cash Fund shall be used to disburse for non-recurring, emergency and petty expenses that do not necessitate the issuance of a check;
