RESOLUTION AMENDING RESOLUTION NO. 21-358 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR A FINANCIAL ASSISTANCE AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (PHP 500,000.00) AS SUPPORT TO THE BAGO CITY PNP PROGRAMS AND SERVICES".

WHEREAS, letter dated January 4, 2022, from the Honorable City Mayor, addressed to this Honorable Body, the request for a passage of a resolution amending Resolution No. 21-358, Series of 2021 entitled: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE PROVINCE OF NEGROS OCCIDENTAL AS SUPPORT TO THE BAGO CITY PNP PROGRAMS AND SERVICES" to "**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR A FINANCIAL ASSISTANCE AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (PHP 500,000.00) AS SUPPORT TO THE BAGO CITY PNP PROGRAMS AND SERVICES**";
