RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT AND CONTRACT OF USUFRUCT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF TRADE AND INDUSTRY-REGIONAL OFFICE VI AND THE CITY GOVERNMENT OF BAGO IN THE IMPLEMENTATION OF "SHARED SERVICE FACILITIES (SSF) PROJECT" AS ASSISTANCE TO 120 MEMBERS COFFEE GROWERS IN THE CITY OF BAGO.

WHEREAS, letter dated January 4, 2022, from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and on behalf of the City of Bago in the Memorandum of Agreement and Contract of Usufruct to be executed by and between the Department of Trade and Industry-Regional Office VI and the City Government of Bago in the implementation of "Shared Service Facilities (SSF) Project" as assistance to 120 members coffee growers in the City of Bago;
