**RESOLUTION NO. 22-015**

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF LEASE TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRARIAN REFORM (DAR) AND THE CITY GOVERNMENT OF BAGO TO LEASED-OUT A COMMERCIAL PROPERTY OWNED BY THE CITY OF BAGO SITUATED AT THE REGIONAL TRIAL COURT COMPOUND, RAFAEL SALAS DRIVE, BARANGAY LAG-ASAN, BAGO CITY, FOR A MONTHLY RENTAL OF FOUR THOUSAND FIVE HUNDRED PESOS (₱4,500.00) IN PHILIPPINE CURRENCY.

**WHEREAS**, letter dated January 11, 2022, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a resolution authorizing him to sign for and on behalf of the City of Bago in the Contract of Lease to be executed by and between the Department of Agrarian Reform (DAR) and the City Government of Bago to leased-out a commercial property owned by the City of Bago situated at the Regional Trial Court Compound, Rafael Salas Drive, Barangay Lag-asan, Bago City, for a monthly rental of Four Thousand Five Hundred Pesos (₱4,500.00) in Philippine Currency;
