RESOLUTION EXTENDING THE DEADLINE FOR THE RENEWAL OF BUSINESS PERMIT AND MOTORIZED TRICYCLE OPERATOR'S PERMIT AND OTHER LICENSES IMPOSED BY THE CITY UNDER THE REVISED LOCAL REVENUE CODE OF 2017 TO JANUARY 31, 2022.

WHEREAS, in an endorsement letter dated January 11, 2022, from the Honorable City Mayor, respectfully referred to the Honorable Members, Sangguniang Panlungsod, this City, a communication from Mr. Caruso T. Villaflor, Jr., City Treasurer, also of this City, requesting for the passage of a resolution extending the deadline for the Renewal of Business Permit and Motorized Tricycle Operator's Permit and other Licenses imposed by the City under the Revised Local Revenue Code of 2017 to January 31, 2022 due to the current Health Emergency situation in the city without surcharge, interest and penalties to give the taxpayers ample time to secure clearances from various agencies;

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;
