RESOLUTION EXTENDING THE DEADLINE FOR THE RENEWAL OF BUSINESS PERMIT AND MOTORIZED TRICYCLE OPERATOR'S PERMIT AND OTHER LICENSES IMPOSED BY THE CITY UNDER THE REVISED LOCAL REVENUE CODE OF 2017 FROM FEBRUARY 1 – 28, 2022.
