RESOLUTION INTERPOSING NO OBJECTION TO THE TRANSFER OF A PERMIT OF MR. JOERESTY T. ABELIDA, THE TRANSFEREE OF A WAIVER OF RIGHTS DATED 24 OCTOBER 2021 EXECUTED BY DR. PRISCILLA G. PLANTA OVER THE GOVERNOR'S PERMIT TO QUARRYING ISSUED TO THE LATTER'S FAVOR.

WHEREAS, in a letter dated February 14, 2022 from Mr. Vicente D. Mesias, City ENRO and favorably endorse by the Honorable City Mayor, the request for the passage of a Resolution interposing no objection to the transfer of a permit of MR. JOERESTY T. ABELIDA, the transferee of a waiver of rights dated 24 October 2021 executed by Dr. Priscilla G. Planta over the governor's Permit quarrying issued to the latter's favor;
