## **RESOLUTION NO. 22-053**

RESOLUTION AMENDING RESOLUTION NO. 21-213: RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO SIGN IN THE DEED OF DONATION OF VARIOUS EQUIPMENT IN FAVOR OF THE CITY FROM THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL, PARTICULARLY NUMBER 4 DONATION TO BE READ AS FOLLOWS: 4.) 2 UNIT PADDLED BOARD SPLINT KIT (ORANGE VINYL COVERED SPLINTS WITH ½" FOAM ON ONE SIDE; SET INCLUDES TWO EACH OF 15", 36" AND 54" AND ONE CARRY CASE), EPP, MADE IN CHINA.

**WHEREAS,** letter dated March 1, 2022, from the Honorable City Mayor, respectfully referred to this Honorable Body, the request for the passage of a resolution amending Resolution No. 21-213 granting him authority to sign in the Deed of Donation of various equipment in favor of the City from the Provincial Government of Negros Occidental, particularly number 4 donation;

WHEREAS, said amendment for the donations as follows:

- 1.) 2 Unit Torpedo buoy, HDPE, 3 handles, with rope, EPP, made in China
- 2.) 6 Unit Rescue Life vest, heavy-duty, Aqualife, made in the Philippines
- 3.) 1 Unit Spine board, with spider strap bundle, heavy-duty, EPP, made in China
- 4.) 2 Unit Paddled board splint kit (orange vinyl covered splints with ½" foam on one side; set includes two each of 15", 36" and 54" and one carry case), EPP, made in China;

**WHEREAS,** after thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on the said request;

**NOW, THEREFORE,** upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod
