RESOLUTION NO. 22-064

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF HEALTH-WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT, WHEREIN THE LATTER SHALL PROVIDE AN AMOUNT OF ONE MILLION PESOS (₱1,000,000.00) FOR THE COMPLETION/UPGRADING/REPAIR OF BARANGAY ILIJAN BHS.

WHEREAS, the Honorable City Mayor, on March 15 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Department of Health-Western Visayas Center for Health Development, wherein the latter shall provide an amount of One Million Pesos (₱1,000,000.00) for the Completion/Upgrading/Repair of Barangay Ilijan BHS;

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;

NOW, THEREFORE, upon motion of SP Member Andrew Martin Y. Torres, unanimously seconded by SP Members present, the Sangguniang Panlungsod
