RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE RENEWAL OF CONTRACT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND RIVERSIDE MEDICAL CENTER, INC., FOR THE CONDUCT OF LABORATORY AND DIAGNOSTICS TESTS (CT-SCAN), ULTRASOUND, & X-RAY PROCEDURES) IN COMPLIANCE WITH PHILHEALTH "NO BALANCE BILLING POLICY" FOR INDIGENT PATIENT.

WHEREAS, the Honorable City Mayor, on March 22, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Renewal of Contract to be executed by and between the City Government of Bago and Riverside Medical Center, Inc., for the conduct of laboratory and diagnostics tests (CT-SCAN), Ultrasound, & X-Ray Procedures) in compliance with PHILHEALTH "No Balance Billing Policy" for indigent patient;
