RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND CENTRAL NEGROS ELECTRIC COOPERATIVE, INCORPORATED FOR THE INSTALLATION OF EXTENSION LINES AND 3-37.5 KVA DISTRIBUTION TRANSFORMER TO BE USE IN THE ISOLATION FACILITY OF THE CITY LOCATED AT BARANGAY NAPOLES, BAGO CITY.

**WHEREAS**, the Honorable City Mayor, on March 22, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Central Negros Electric Cooperative, Incorporated for the installation of extension lines and 3-37.5 kVA distribution transformer to be use in the isolation facility of the City located at Barangay Napoles, Bago City;
