ZERRUDO TO PROVIDE HER EXPERTISE AS PROFESSIONAL LICENSED ORTHOPEDICS AND ASSIST THE MEDICAL OFFICERS OF THE BAGO CITY HOSPITAL.

WHEREAS, the Honorable City Mayor, on March 29, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Dr. Emily M.
