RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF AFFILIATION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND UNIVERSITY OF ST. LA SALLE, INC., FOR THE AFFILIATION AND TRAINING OF THEIR NURSING STUDENTS TO OUR RURAL HEALTH UNITS.

WHEREAS, the Honorable City Mayor, on April 18, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Contract of Affiliation to be executed by and between the City Government of Bago and University of St. La Salle, Inc., for the affiliation and training of their nursing students to our Rural Health Units;
