RESOLUTION NO. 22-100

RESOLUTION INTERPOSING NO OBJECTION ON THE CUTTING/BALLING OF THE AFFECTED TREES WITHIN THE ROAD RIGHTS OF WAY LIMITS, FOR THE PROPOSED CY 2022 PROJECT OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) ON THE WIDENING OF JUNCTION MURCIA-CANSILAYAN-DAMSITE-ABUANAN ROAD AND DON JORGE ARANETA-AYUNGON-YUNGUE-GURREA-LA CARLOTA CITY ROAD, LOCATED AT BARANGAYS ABUANAN, DON JORGE ARANETA AND ALIANZA, ALL OF THIS CITY.

WHEREAS, the Department of Public Works and Highways (DPWH) will be implementing the proposed CY 2022 project, the widening of Junction Murcia-Cansilayan-Damsite-Abuanan Road and Don Jorge Araneta-Ayungon-Yungue-Gurrea-La Carlota City Road, located at Barangays Abuanan, Don Jorge Araneta and Alianza, within the City;

WHEREAS, trees of various species within the road right-of-way limits will be affected by the said project and need to be cut/balled to give way to the widening activities;

WHEREAS, the matter was referred to the Engineering and Public Works Committee, which favored approval of the request, and the Plenary, after a thorough consideration of the matter, unanimously approved the recommendation;

NOW, THEREFORE, upon motion of SP Member Ma. Femmy A. Martir, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to interpose no objection on the cutting/balling of the affected trees within the road rights of way limits, for the proposed CY 2022 project of the Department of Public Works and Highways (DPWH) on the Widening of Junction Murcia-Cansilayan-Damsite-Abuanan Road and Don Jorge Araneta-Ayungon-Yungue-Gurrea-La Carlota City Road, located at Barangays Abuanan, Don Jorge Araneta and Alianza, all of this City.
