RESOLUTION INTERPOSING NO OBJECTION ON THE REMOVAL OF MANGROVES TO GIVE WAY TO THE CONSTRUCTION PROJECT: "CONSTRUCTION OF FLOOD CONTROL STRUCTURE AT CALUMANGAN RIVER, BARANGAY CALUMANGAN, BAGO CITY, NEGROS OCCIDENTAL" OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), NEGROS OCCIDENTAL 4TH DISTRICT ENGINEERING OFFICE.

WHEREAS, the Department of Public Works and Highways (DPWH), Negros Occidental 4th District Engineering Office will be implementing the project "Construction of Flood Control Structure at Calumangan River, Barangay Calumangan, Bago City, Negros Occidental";
