RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A DEED OF ABSOLUTE SALE BETWEEN THE CITY OF BAGO AND HEIRS OF MARIANITO M. VITO, SR. AND ERLINDA MALUNES.

WHEREAS, the Honorable City Mayor, on April 27, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in a Deed of Absolute Sale between the City of Bago and Heirs of Marianito M. Vito, Sr. and Erlinda Malunes;

WHEREAS, said Deed of Absolute Sale pertains to a parcel of land intended for the expansion of the sanitary landfill located at Barangay Ma-ao, this City, with an area of Forty-Two Thousand Seven Hundred and Thirty Eight (42,738) square meters;

WHEREAS, after a thorough consideration of the matter, the members of this Honorable body have unanimously agreed to act in favour of the above request;
