RESOLUTION NO. 22-110

RESOLUTION ADOPTING EXECUTIVE ORDER NO. 29-A, SERIES OF 2021, ENTITLED: "AN ORDER ADOPTING THE PROTOCOL FOR CASE MANAGEMENT OF CHILD ABUSE, NEGLECT AND EXPLOITATION OF THE NATIONAL COMMITTEE ON SPECIAL PROTECTION OF CHILDREN AND THE COMPREHENSIVE BARANGAY JUVENILE INTERVENTION PROGRAM OF THE JUVENILE JUSTICE WELFARE COUNCIL (JJWC) IN THE CITY OF BAGO".

WHEREAS, the Honorable City Mayor Nicholas M. Yulo issued on July 29, 2021, Executive Order No. 29-A, Series of 2021, entitled: "AN ORDER ADOPTING THE PROTOCOL FOR CASE MANAGEMENT OF CHILD ABUSE, NEGLECT AND EXPLOITATION OF THE NATIONAL COMMITTEE ON SPECIAL PROTECTION OF CHILDREN AND THE COMPREHENSIVE BARANGAY JUVENILE INTERVENTION PROGRAM OF THE JUVENILE JUSTICE WELFARE COUNCIL (JJWC) IN THE CITY OF BAGO";

WHEREAS, the Local Council for the Protection of Children (LCPC) deem the need to adopt the Protocol on Case Management of Child Abuse, Neglect, and Exploitation of the National Committee on Special Protection of Children and the Comprehensive Barangay Juvenile Intervention Program of the Juvenile Justice Welfare Council (JJWC) in the City of Bago in order to improve services and case management on this vulnerable sector;

WHEREAS, after a thorough consideration of the matter, the August body unanimously adopt the above executive order;
