RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CENTRAL NEGROS ELECTRIC COOPERATIVE, INCORPORATED AND CITY OF BAGO, FOR THE ELECTRICAL WORKS TO BE UNDERTAKEN AT BUENOS AIRES MOUNTAIN RESORT.

WHEREAS, the Honorable City Mayor, on May 2, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the Central Negros Electric Cooperative, Incorporated and City of Bago, for the electrical works to be undertaken at Buenos Aires Mountain Resort;

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;
