RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF AGRARIAN REFORM (DAR), PAGHIDA-ET FARM WORKERS ASSOCIATION (PAFWA) AND CITY OF BAGO.

WHEREAS, the Honorable City Mayor, on May 2, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing him to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and among the Department of Agrarian Reform (DAR), Paghida-et Farm Workers Association (PAFWA) and City of Bago;

WHEREAS, the above memorandum of agreement is related to the construction of water concrete tank and pipelines for the purpose of increasing farm productivity, ensure food and nutrition security and mitigate hunger;

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;

NOW, THEREFORE, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod
