ERNA T. ELIZAN, DIRECTOR III, CIVIL SERVICE COMMISSION REGIONAL OFFICE VI FOR THE CONDUCT OF "WRITE-UP" TECHNICAL SKILLS TRAINING TO BE CONDUCTED ON MAY 31-JUNE 1, 2022 FOR THE CITY EMPLOYEES.
