RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF AGRICULTURE, FOR THE IMPLEMENTATION OF "SWINE RESTOCKING" UNDER THE DEPARTMENT OF AGRICULTURE LIVESTOCK LIVELIHOOD ASSISTANCE PROGRAM.

WHEREAS, the Honorable City Mayor, on June 14, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and the Department of Agriculture, for the implementation of "Swine Restocking" under the Department of Agriculture Livestock Livelihood Assistance Program;
