RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF UNDERSTANDING TO BE EXECUTED BY AND AMONG THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL, NIA, DAR, LANDBANK, TESDA, DTI, DOST, DA AND LGUS OF MOISES PADILLA, MURCIA AND CITY OF BAGO, FOR THE ENHANCED PARTNERSHIP AGAINST HUNGER AND POVERTY (EPAHP) PROGRAM.
