RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF HEALTH AND THE CITY OF BAGO, FOR THE PROCUREMENT AND CONSTRUCTION OF BAGO CITY SUPER HEALTH CENTER AMOUNTING TO TEN MILLION PESOS (\$\mathbf{P}\$10,000,000.00).

WHEREAS, the Honorable City Mayor, on June 21, 2022, wrote to this Honorable Body, requesting for the passage of a Resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the Department of Health and the City of Bago, for the procurement and construction of Bago City Super Health Center amounting to Ten Million Pesos (₱10,000,000.00);

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request.

NOW, THEREFORE, upon motion of SP Member Jozsef Mark Dexter M. Somcio, unanimously seconded by SP Members present, the Sangguniang Panlungsod
