RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF EDGARDO UYCHIAT FOR THE PROPOSED UJ HINALUAN CREEK HOA INC. PHASE 1 HOUSING PROJECT LOCATED AT BARANGAY MA-AO, THIS CITY, CONTAINING AN AREA OF TWENTY TWO THOUSAND FIVE HUNDRED SEVEN (22,507) SQUARE METERS UNDER TCT NO. 093-2013000114, TCT NO. T-23502 AND T-23503 INTO ONE HUNDRED THIRTY ONE (131) SUBLOTS.

WHEREAS, in a letter dated June 20, 2022, from Engr. Deny L. Millevo, Assistant City Assessor/Housing Regulation Officer-Designate/Zoning Officer-Designate, addressed to the Honorable Jorge Agustin Araneta, Chairman, Committee on Landed Estates, the request for approval of the application for Preliminary Approval and Locational Clearance of EDGARDO UYCHIAT for the Proposed UJ HINALUAN CREEK HOA INC.
