**RESOLUTION APPROVING RESOLUTION NO. 07, SERIES OF 2022 OF THE CITY DEVELOPMENT COUNCIL, BAGO CITY, ENTITLED: "RESOLUTION APPROVING THE PROGRAMS, PROJECTS, AND ACTIVITIES TO BE FUNDED AGAINST THE CY 2023 1% LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) FUND IN THE AMOUNT OF ELEVEN MILLION PESOS (PHP11,000,000.00)".**

**WHEREAS**, Indorsement letter dated June 11, 2022, from the Honorable City Mayor, respectfully referred to this Honorable body, the request for approval of Resolution No.07, Series of 2022 of the City Development Council, Bago City;

**WHEREAS**, Section 15 of Republic Act No. 9344, known as the "Juvenile Justice and Welfare Act of 2006" mandates local government units to establish their respective Local Council for the Protection of Children (LCPC) at the City, Municipal, and Barangay Levels and allocate 1% of Internal Revenue Allotment (IRA) for its strengthening and implementation of programs, projects, and activities;

**WHEREAS**, the LCPC is an institutional mechanism in all levels of LGUs that advocates child rights, plans and initiates/recommends interventions and monitors children's programs and projects in the locality;

**WHEREAS**, after a thorough deliberation on the matter, this August Body is of the consensus to approve said Resolution.

**NOW, THEREFORE**, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved, to approve Resolution No. 07, Series of 2022 of the City Development Council, Bago City, entitled: "Resolution Approving the Programs, Projects, and Activities to be Funded Against the CY 2023 1% Local Council for the Protection of Children (LCPC) Fund in the amount of Eleven Million Pesos (Php11,000,000.00)".
