RESOLUTION APPROVING RESOLUTION NO. 08, SERIES OF 2022 OF THE CITY DEVELOPMENT COUNCIL, BAGO CITY, ENTITLED: "RESOLUTION APPROVING THE BAGO CITY LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMF) FOR CY 2023 IN THE AMOUNT OF SIXTY FOUR MILLION FIVE HUNDRED ELEVEN THOUSAND SIX HUNDRED FIFTY PESOS (PHP64,511,650.00)".

WHEREAS, Indorsement letter dated June 11, 2022, from the Honorable City Mayor, respectfully referred to this Honorable body, the request for approval of Resolution No.08, Series of 2022 of the City Development Council, Bago City;

WHEREAS, Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 transform the Philippine's disaster management system from disaster relief and response towards disaster risk reduction (DRR);

WHEREAS, Section 15 of the aforementioned Act has considered the local government units (LGUs) as the frontliners and "first responders" in every disaster event;

WHEREAS, Section 16 of R.A. No. 10121 provides that a Local DRRM Plan will be formulated by the LDRRMOs in close coordination with the local development councils;

WHEREAS, after a thorough deliberation on the matter, this August Body is of the consensus to approve said Resolution.

NOW, THEREFORE, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to approve Resolution No. 08, Series of 2022 of the City Development Council, Bago City, entitled: "Resolution Approving the Bago City Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMF) for CY 2023 in the amount of Sixty Four Million Five Hundred Eleven Thousand Six Hundred Fifty Pesos (Php64,511,650.00)".
