RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BAGO AND THE CIVIL SERVICE COMMISSION, IN RELATION TO THE CONDUCT OF A THREE (3) DAYS SEMINAR WORKSHOP ON THE IMPROVEMENT OF FRONTLINE TRANSACTIONS (SWIFT).
