WHEREAS, Indorsement letter dated July 26, 2022, from the Honorable City Mayor, respectfully referred to this Honorable body, the request for approval of Resolution No.3, Series of 2022 of the City Development Council, Bago City;

WHEREAS the construction of satellite market projects in Barangays Malingin, Pacol, Busay and Atipuluan has been approved and included in the CY 2021 Annual Investment Program;

WHEREAS, in a letter from the City Engineer to the Honorable City Mayor, it was requested that the project Construction of Satellite Market at Barangays Malingin, Pacol, Busay and Atipuluan be changed to Construction of Satellite Market at Barangays Malingin, Pacol, Balingasag and Atipuluan;

WHEREAS, the City Engineer has stated in a letter that the reason for the transfer is that Barangay Busay was not able to provide the site for the satellite market;
