RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES VISAYAS AND THE CITY GOVERNMENT OF BAGO, IN RELATION TO THE SUPERVISED INDUSTRIAL TRAINING PROGRAM.
