RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND PROVINCE OF NEGROS OCCIDENTAL IN RELATION TO THE IMPLEMENTATION OF THE NEGROS OCCIDENTAL SCHOLARSHIP PROGRAM.

WHEREAS, letter dated September 16, 2022, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Province of Negros Occidental in relation to the implementation of the Negros Occidental Scholarship Program;
