RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND CITY GOVERNMENT OF BAGO IN RELATION TO THE FINANCIAL ASSISTANCE OF THE PROVINCE TO THE CITY IN ITS PARTICIPATION ON THE 1ST MASSKARA SA PANAAD.
