BENARES TO PROVIDE HER EXPERTISE AS A LICENSED MEDICAL DOCTOR IN THE FIELD OF PEDIATRIC SERVICES AT BAGO CITY HOSPITAL.

WHEREAS, letter dated September 27, 2022, from the Honorable City Mayor, addressed to the Honorable Members Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Dr. Irene C.
