## **RESOLUTION NO. 22-271**

RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF THE FOLLOWING CIVIL SOCIETY ORGANIZATION (CSO) IN THE CITY OF BAGO, PROVINCE OF NEGROS OCCIDENTAL.

- 1. BAGO ANTI-CRIME GROUP ORGANIZATION (BAGO), INC.
- 2. AMICUS AGRARIAN REFORM ASSOCIATION
- 3. CALUMANGAN INTEGRATED FARMERS AND FARM WORKERS ASSOCIATION (CALIFWA).

WHEREAS, Section 34 of the Local Government Code of 1991 (Book1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the above-named CSOs, through its President/Executive Director or equivalent, has signified its intention to be an accredited CSO in the City of Bago, Province of Negros Occidental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the above-named CSOs has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2022-083;

WHEREFORE, on motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panungsod, be it;

RESOLVES, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod to approve and grant the accreditation of the stated Civil Society Organization (CSO) in the City of Bago, Province of Negros Occidental.

**RESOLVED FURTHER,** that this accreditation is effective only until June 30, 2025.
