WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request.

NOW, THEREFORE, upon motion of SP Member Joseph J. Colmenares, unanimously seconded by SP Members present, the Sangguniang Panlungsod
