RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE PROVINCE OF NEGROS OCCIDENTAL IN RELATION TO THE IMPLEMENTATION OF REPUBLIC ACT 7719 OTHERWISE KNOWN AS THE "NATIONAL BLOOD SERVICES ACT OF 1994".

WHEREAS, letter dated October 17, 2022, from the Honorable City Mayor, addressed to the Honorable Members Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Province of Negros Occidental in relation to the implementation of Republic Act 7719 otherwise known as the "National Blood Services Act of 1994";

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request.
