RESOLUTION AUTHORIZING THE CITY TREASURER TO RE-ACTIVATE, CLOSE AND TRANSFER OF THE CITY ACCOUNT MAINTAINED AT LANDBANK OF THE PHILIPPINES-BACOLOD CITY UNDER THE ACCOUNT NAME CENPRI-DLF (ER 1-94) WITH ACCOUNT NUMBER 0422-1351-54 AND CENPRI-RWMHEEF (ER 1-94) WITH ACCOUNT NUMBER 0422-1351-46 TO LANDBANK OF THE PHILIPPINES-BAGO CITY AGRI HUB AND TO CLOSE THE CITY ACCOUNT NAMED BAGO CITY COLLEGE-CHED UNIFAST WITH ACCOUNT NUMBER 0422-1319-14 AND TRANSFER IT TO LANDBANK OF THE PHILIPPINES-BAGO CITY AGRI HUB.
