WHEREAS, in a letter dated September 22, 2022, from Mr. Vicente Mesias, City ENRO, noted by the Honorable City Mayor and favorably endorsed to this Honorable body, the documentary requirements of the application of MS. MONICA MARIE T. AGUILAR, for a favorable endorsement of Industrial Sand and Gravel (ISAG) Project, with an area of 4.9773 hectares over a portion at Bago River located at Barangays Atipuluan and Ma-ao, both of Bago City;


