RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE MARIETTA FARMS AGRARIAN REFORM BENEFICIARIES IN RELATION TO THE GIVING BY THE CITY OF FINANCIAL SUPPORT AS PART OF ITS LIVELIHOOD ASSISTANCE PROGRAM.
