RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BARANGAY BAGROY, BAGO CITY FOR A FINANCIAL ASSISTANCE TO BE USED FOR SPOT PATCHING OF SEVERELY DAMAGED GRAVEL ROAD IN BARANGAY BAGROY, THIS CITY AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (P500,000.00) ONLY.

WHEREAS, letter dated November 22, 2022, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Project Proposal and Memorandum of Agreement to be executed by and between the City Government of Bago and Barangay Bagroy, Bago City for financial assistance to be used for spot patching of severely damaged gravel road in Barangay Bagroy, this City, amounting to Five Hundred Thousand Pesos (P500,000.00) Only;
