RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO INCUR OBLIGATIONS CHARGEABLE AGAINST THE LUMP-SUM APPROPRIATION FOR CAPITAL EXPENDITURES AND MAINTENANCE AND OTHER OPERATING EXPENDITURES FOR CALENDAR YEAR 2023 AND AUTHORIZING THE SAME TO ENTER INTO CONTRACT TO THE LOWEST CALCULATED RESPONSIVE BID, AS MANDATED UNDER MEMORANDUM NO. 2010-14 OF THE COMMISSION ON AUDIT, IN ORDER NOT TO DELAY THE IMPLEMENTATION OF VARIOUS PROGRAMS AND PROJECTS FOR CALENDAR YEAR 2023.
