RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT AND DEED OF DONATION BETWEEN THE CITY OF BAGO AND DENR ENVIRONMENTAL MANAGEMENT BUREAU-REGION VI IN RELATION TO THE INSTALLATION OF BRAND NEW PRELIMINARY DISINFECTION AND STORAGE FACILITY FOR COLLECTED COVID-19 RELATED WASTE IN THE CITY OF BAGO.

WHEREAS, letter dated December 27, 2022, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement and Deed of Donation between the City of Bago and DENR Environmental Management Bureau-Region VI in relation to the installation of Brand New Preliminary Disinfection and Storage Facility for Collected COVID-19 Related Waste in the City of Bago;
