RESOLUTION NO. 22-351

RESOLUTION ADOPTING ADMINISTRATIVE ORDER NO. 3 OF PRESIDENT FERDINAND R. MARCOS, JR., "AUTHORIZING THE GRANT OF GRATUITY PAY TO CONTRACT OF SERVICE AND JOB ORDER WORKERS IN GOVERNMENT FOR FISCAL YEAR 2022" IN THE AMOUNT OF THREE THOUSAND PESOS (PHP3,000.00) ONLY.

WHEREAS, in a letter dated December 27, 2022, from the Honorable City Mayor, addressed to this Honorable body, the request for the passage of a resolution adopting Administrative Order No. 3 of President Ferdinand R. Marcos, Jr., "Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2022" in the amount of Three Thousand Pesos (PHP3,000.00) only;

WHEREAS, after a thorough deliberation on the matter, it was the consensus of this August body to grant Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2022 in the amount of Three Thousand Pesos (PHP3,000.00) only subject to the following conditions:

1. All employees who are occupying Contract of Service and Job Orders positions;
2. The employees are still active in the government service as of 15 December 2022;
3. Employees who have rendered less than four (4) months of service as of 15 December 2022 shall be entitled to a pro-rated share as follows:

| Length of Service | Amount of Gratuity Pay |
|---------------------------------|-------------------------|
| 3 months but less than 4 months | Not exceeding P2,400.00 |
| 2 months but less than 3months | Not Exceeding P1,800.00 |
| Less than 2 months | Not Exceeding P1,200.00 |

NOW, THEREFORE, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to adopt Administrative Order No. 3 of President Ferdinand R. Marcos, Jr., "Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2022" in the amount of Three Thousand Pesos (PHP3,000.00) only.
