RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY NEGROS OCCIDENTAL DISTRICT JAIL CONCERNING THE OFFERING BY THE BAGO CITY COLLEGE OF A BACHELOR OF SCIENCE IN OFFICE ADMINISTRATION DEGREE TO THE QUALIFIED INMATES OF THE NEGROS OCCIDENTAL DISTRICT JAIL AS PART OF THE COMMUNITY EXPANSION PROGRAM.

WHEREAS, in a letter dated November 17, 2023, from Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Bureau of Jail Management and Penology Negros Occidental District Jail in relation to the offering by the Bago City College of a Bachelor of Science in Office Administration degree to the qualified inmates of the Negros Occidental District Jail as part of the community expansion program;
