**RESOLUTION NO. 23-416**

**RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF THE FOLLOWING CIVIL SOCIETY ORGANIZATION (CSO) IN THE CITY OF BAGO, PROVINCE OF NEGROS OCCIDENTAL.**

**1. NEGROS ISLAND ORGANIC PRODUCERS ASSOCIATION (NIOPA).**

**WHEREAS**, Section 34 of the Local Government Code of 1991 (Book1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

**WHEREAS**, the above-named CSOs, through its President/Executive Director or equivalent, has signified its intention to be an accredited CSO in the City of Bago, Province of Negros Occidental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;




