RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BAGO IN CONNECTION WITH A DONATION OF A PARCEL OF LAND WITH AN AREA OF SEVEN HUNDRED AND NINETY-EIGHT SQUARE METERS (798.00 SQ. M.) WHICH IS A PORTION OF LOT NO. 392 AS ROAD RIGHT-OF-WAY FOR THE BANTAYAN-PESCADORES ACCESS ROAD.

WHEREAS, in an Indorsement letter dated December 11, 2023, from the Acting City Mayor, Honorable Ramon D. Torres, respectfully referred to the Honorable Members, Sangguniang Panlungsod, this City, the request of Engr. Joenil B. Lavadia, City Engineer, this City, for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City Government of Bago in connection with a donation of a parcel of land with an area of seven hundred and ninety-eight square meters (798.00 sq. m.) which is a portion of lot no. 392 as road right-of-way for the Bantayan-Pescadores Access Road;

WHEREAS, said parcel of land is owned by Margie D. Canillo who is married to Bernhardt Bacher;
